

## CARE & MAINTENANCE

Keep hot pans and heating appliances off Topstone. Use pads to protect the surface.

Avoid exposure to strong chemicals. If spills do occur, first wash the surface immediately with pure water and then clean with a solution of water and a slight amount of an ammonia based cleanser.

Use a cutting board instead of cutting directly on Topstone.

The Topstone surface is completely restorable as the solid pattern goes all the way through to the back. Remove scratches and cuts by sanding the damaged areas with a fine 180-220 sandpaper. Then apply an abrasive cleanser and rub with a green Scotch-Brite® (registered trademark of 3M Company) pad until the surface is completely restored. Difficult stains can also be removed with the Scotch-Brite® pad.

Use a diluted solution of water and an ammonia based cleanser for removing most stains or dirt and dry with a cloth towel.

For general maintenance, just rub with a Scotch-Brite® pad.

### LIFETIME RESIDENTIAL LIMITED WARRANTY

This warranty service is available only by written notice to Halstead International or through the dealer from whom the Topstone was purchased. Notification must be accompanied by a copy of the original invoice and can only be authorized by Halstead.

### COMMERCIAL 15 YEAR LIMITED WARRANTY

Halstead International will furnish a replacement of any Topstone that is found to be defective, including labor, if it has been installed and maintained according to the instructions contained in this brochure subject to the following terms:

The replacement will be effected if the defect was not obvious at the time of installation. For the first 5 years, the replacement will be free of charge. Thereafter the replacement charge will be prorated according to the number of years in use or, Halstead may, in its sole discretion, arrange for the repair and restoration free of charge.

This warranty shall not include loss of time, inconvenience, incidental expenses, or consequential damages.
